3. **NOW THEREFORE**, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act. 1993, the Eastern Regional Committee, NCTE hereby grants recognition/permission to **Subhadra Pal PTI, Plot No.- 2251, 2252, 2253, 2285, 1785/2750, Vill- Jamuar, PO- Senda Jamuar, Tehsil/Taluka- Raghunathganj, Town/City- Raghunathganj, Dist- Murshidabad, West Bengal- 742235** for conducting **D.El.Ed.(Additional Intake)** programme of two years duration with an **additional intake of 50 (additional one unit), (existing 50 intake + additional 50 intake), thus making the total intake of 100 (one hundred)** from the academic session **2016-2017** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.

- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.

4. The recognition/permission is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-2017.

    - i) The affidavit with enclosure submitted along with application;
